## Overview:

This first eight hours has produced a good number of records for you. Subsequent assignments cannot be this highly productive because of the time period we've reached.

The family group sheet you provided lists your Thomas A. Goodson with a birthdate of 6 November 1863, and your Sarah E. Nunnally, 22 May 1871. You provided a copy of their marriage record, 20 October 1885, Warren County, Tenn.

Many of the early records of Warren County have been transcribed or abstracted and published by private individuals. These were the sources I primarily used in this assignment, although in several instances I did go to the actual records [on microfilm] to make copies for you.

The transcribed and published 1870 census of Warren County, Tenn. lists only one household of Goodsons, and in that household is a Thomas A., age 6 [born ca 1864].

This family is living in 1880 only two doors from the Nunnelly family that has a daughter named Sarah, age 9—which matches what we know about your Sarah. [I did look at all other Nunnelly households in this county, finding no others with a Sarah anywhere near this age.]

**Comment:** These two William's are only a year apart in age, but we can distinguish which is yours by the name of the wife and the children. It would be interesting to learn what General Nunley's full name was. It's most unusual to see so many initials (G.J.M.B.E.).

By 1840 there are **four** households headed by a William Nunley:

Age groupings shown on the 1840 census are 0-5, 5-10, 10-15, 15-20, 20-30, 30-40, 40-50, etc. Only the head of household is listed by name.

#### **Nunnelly Summary:**

Other than one other source, this is as far as I have gone with your Nunnellys. Obviously what is now needed is an examination of court records (deeds, wills, marriages). As mentioned in an earlier letter, this county does have gaps in its surviving records (especially early marriages and court minutes). The collection of Thomas Barnes, postman of Warren County, genealogist, and the county's historian for many years, is available at the Tennessee State Library and Archives. This material is not documented in any fashion, but can lend important clues. For the Nunleys I have photocopied for you the page on Nunleys that refers to *your* family. Mr. Barnes has added dates and data that need verifying, if possible, such as:

- that William Nunley's wife was Mahala **Tate**,
- that he (or she) was born 25 April 1807 and died 26 May 1896[?],
- the names of several of the children's spouses,
- and that General Nunnelly was married to Bettie **Gribble**.

**Comment:** I must emphasize that this data bears no documentation, so we cannot take it at face value, but must use it as clues to help us determine their accuracy.

#### **Further on the Goodsons:**

As above detailed, I have shown Thomas A. (Atlas) in Anderson Goodson's household on the 1870 and 1880 Warren County censuses. I've been unable to find this family in 1860 Warren or indeed in any Tennessee county (searching the publication, *1860 Census of Tennessee*, by Byron and Barbara Sistler, Vol. 4, Crai-Haines (Nashville: Byron Sistler and Associates, 1981). The family may have been in Arkansas (the 1870 Warren census lists children born in Arkansas in 1858 and 1860). Also, I've not been able to find the family on the 1850 census of Tennessee, using both the published 1850 Warren County Census and Sistler's *1850 Census of Tennessee*.

Anderson's household in 1870 has children born 1846 and 1855 in Georgia. A published index to the heads of households *only* for Georgia (*Index to 1850 Census of Georgia*, by R. V. Jackson (Bountiful, Utah: AIS, 1976) led me to Carroll County, Georgia and the household of Andrew Goodson—which turned out to be your A.J./Anderson—but listed as Andrew this time:

**Comment:** We can identify this as your Anderson because of his age, his wife's name, and the son named Milas.

**Comment:** Because she is old enough to have been Andrew/Anderson's mother, I am naturally interested in her. To date, though, I've found little to help us. (See following.)

In this same census of 1850 Carroll County, Ga. is a Michael Goodson, age 29, merchant, born North Carolina, in the household of M. S. Burns 41 of South Carolina. (See my attached notes.)

The published index to the 1840 census of Georgia lists two Goodsons in Carroll County: George W. and Lydia. On the actual census (copies enclosed), these households are as follow:

**Comment:** As your Anderson/Andrew Goodson was born ca 1813-1817, he would have been about 23-27 in 1840. No male of that age is in Lydia's household, and the one of that age in George's household would be George

himself. It's possible that Andrew/Anderson was living in another household (perhaps as a farm laborer) and thus was counted in *that* household.

I have access to a limited number of records on Carroll County, Ga.—just those that have been published. My notes show my findings in more depth, but I do want to mention that the deed books show Andrew Goodson buying land there in 1838 (Book C, p. 331) and again in 1842. [I think we can consider his name to have been *Andrew*, not Anderson, since we've found it listed as Andrew on all occasions but one, and since both he and his son Thomas A. named sons Andrew. Census records are notoriously full of errors in names, ages, birthplaces, etc.]

When Andrew bought land in 1838, one of the witnesses was an Abner Goodson. An Abner, age 21, is in the 1850 census of Cass County, Ga., but this couldn't be the Abner of the 1838 deed because he would have been too young in 1838 to witness a deed. He is listed twice in that census, the second time in the household of Joel Goodson, 70, NC, and wife Elizabeth, age 60, NC. This couple's marriage may well be the following found in the microfiche of NC Marriage Bonds:

Goodson, Joel to Elizabeth Brotherton, xx [day not listed] August 1840, Lincoln County, N.C.; bondsman: L.E. Brotherson.

Family Deduction

#### Summary Thoughts:

I'm getting ahead of myself with the research when I extend it to Lincoln County, North Carolina. I mention it only to alert you to the possibility this *may* be the area where your Goodsons formerly lived—but that's just conjecture at this point. My census searches and study of published records has gotten me back to Carroll County, Georgia. However, I now need to go back and exhaust the Warren County, Tennessee records, for there may be clues yet hidden there. It does not pay to skip over records, in the long run. Additionally, there were Goodsons early in adjacent White County, Tenn., among whom was a Michael—a name we've seen in Carroll County, Georgia. So, the White County records should receive attention, as well.

**Comment:** The notes in brackets were added by the compilers. Somewhere there evidently is a record showing Andrew’s wife as Tansy E. A. Thus far I’ve found her to be listed only as Elizabeth.

- Warren County’s marriage records survive back only to 1852. I’ve photocopied for you from Byron Sistler’s transcription of those the Nunnelly and Goodson marriages in the years between 1852-1865.
- A compilation of early Warren County families and history, *The Warren county Story*, by Eugene M. Wiseman [not dated, but ca mid-1990s], describes the early Nunnellys of Warren County as having formerly lived in Rutherford County, North Carolina; again, though, there is no documentation for this statement—but certainly I consider this a good clue to follow. And, A. J. Goodson is cited as having a mill on the Caney Fork River (p.22). Further examination of early Warren County deeds should bring forth more information on this mill.
- A published genealogy on one of Warren County’s early Nunley families has some interesting information, but which is, again, not documented. These were most probably cousins of your William F. Nunnelly. (See attached copies from *Norman Nunley and His Kin*, by Joe E. Nunley and others, 1987.)

**Suggestions for further research:**

Within this report I’ve mentioned several areas that need researching. I hope you will want to continue this work.
